 - 2) Put the samples in the dishwasher;
 - 3) Fill the dishwasher soap holder with the powder detergent, close and lock the dishwasher as recommended in the operating instructions;
 - 4) Run the dishwasher for five (5) cycles with 140°F (60°C) water at "normal setting" for housewares. Each cycle includes soaking, washing and drying;
 - 5) Remove and visually examine each sample.
